DAY 1 MONDAY

We depart tonight from the AMTRAK STATION in St. Paul. Settle in your roomy coach reclining seat as we travel west on AMTRAK'S Superliner-the EMPIRE BUILDER-Welcome Aboard!

DAY 2 TUESDAY

Today we'll travel across North Dakota and Montana in route to Whitefish. Enjoy the scenery from your seat or from the dome car. Meals are available in the dining car or the lounge car before arriving in Whitefish this evening. **ROCKY MOUNTAIN LODGE (2 NIGHTS)**

DAY 3 WEDNESDAY (CB, L, D)

After breakfast at the hotel, we'll tour the Flathead Valley farming area before climbing to the base of WHITEFISH MOUNTAIN for lunch. After lunch, we'll take the ski lift to the summit for spectacular views of the valley and lakes below. Our local guide will then introduce us to Kalispell where we're invited to visit the CONRAD MANSION before returning to the hotel for a pizza party tonight.

DAY 4 THURSDAY (CB, L, D)

This morning our local guide will introduce us to Glacier National Park. After a box lunch at Lake McDonald Lodge, we'll take the famous REDS on the GOING TO THE SUN highway that offers spectacular views of the park. Tonight we'll be in Waterton, Alberta on the Canadian side of this International Peace Park. **WATERTON LAKES LODGE (2 NIGHTS)**

DAY 5 FRIDAY (B, L)

After breakfast, we'll drive north to Ft. Macleod where the Canadian Mounties had an outpost and today share their heritage with a musical ride on horseback in full uniform. After lunch, we'll visit HEAD SMASHED IN Buffalo Jump, a world heritage UNESCO site where we'll have a tour. A free evening tonight in the quaint town of Waterton.

DAY 6 SATURDAY (CB, L, D)

After breakfast at the hotel, we're off to a cruise on Waterton Lake where we'll actually sail back into the USA, crossing the 49th parallel. Then back to Waterton for lunch at the famous PRINCE OF WALES Hotel, overlooking the lake below. After lunch, we'll drive back into the USA for our overnight at the beautiful Glacier Park Lodge built with impressive Douglas Fir logs. Farewell dinner tonight in the dining room. **GLACIER PARK LODGE (1 NIGHT)**

DAY 7 SUNDAY (B)

After breakfast at the hotel, it's a short walk to the AMTRAK station as we await the arrival of the EMPIRE BUILDER. The train departs mid morning as we settle into our comfortable reclining coach seats for our trip back to Minnesota. Lunch and dinner are available on the train again today as we watch the scenery pass by.

DAY 8 MONDAY

We arrive back into the St. Paul AMTRAK station early this morning ending our trip to Montana and the beautiful GLACIER NATIONAL PARK.
